# GERMANY, FRANCE IGNORE WHO CALL

## French Prez says France works on rolling out third vax jabs to elderly and vulnerable from Sept

Germany and France will go ahead with Covid-19 vaccine boosters from September, disregarding an appeal by the World Health Organisation (WHO) to hold off until more people are vaccinated across the globe.

The decision to press ahead with booster shots despite the strongest statement yet from the WHO highlights the challenge of dealing with a global pandemic while countries try to protect their own citizens from the more infectious Delta variant.

French President Emmanuel Macron said France was working on rolling out third Covid vaccine doses to the elderly and vulnerable from September. WHO chief Tedros Adhanom Ghebreyesus called on Wednesday for a halt to vaccine boosters until at least the end of September, saying it was unacceptable for rich countries to use more of the global vaccine supply.

### Henan province expands lockdown area

BEIJING: China on Thursday reported 85 new coronavirus cases, including 62 new locally transmitted ones, as delta variant of the virus spreads in Chinese cities. No deaths related to Covid were reported. Zhengzhou city in Henan province expanded lockdown area of residential communities and escalated epidemic control as the local outbreak continues to spread within the city.

### Melbourne enters 6th lockdown

CANBERRA: Australia's second-largest city Melbourne went into a 6th lockdown on Thursday, with a state government leader blaming the nation's slow Covid-19 vaccination rollout for the decision.

### Lankan hospitals prepare for surge

COLOMBO: Hospitals in Sri Lanka started preparations to face the current surge in the number of Covid-19 cases, deputy director general of health Dr Hemantha Herath said on Thursday.

# 303 Taliban killed in Afghan forces ops in 24 hours: Govt

KABUL: At least 303 Taliban terrorists were killed and 125 others suffered injuries as a result of Afghan forces operation in several provinces in Afghanistan during the last 24 hours, the Afghan defense ministry said on Thursday.

The Afghan National Security Forces (ANSF) carried out operations in Nangarhar, Laghman, Ghazni, Paktika, Kandahar, Zabul, Herat, Jowzjan, Samangan, Faryab, Sare Pol, Helmand, Nimruz, Kunduz, Baghlan and Kapisa provinces during the last 24 hours.

Giving out the details of the operations conducted by the Afghan forces, the Defence Ministry said 16 Taliban terrorists were killed and 10 others wounded in airstrikes conducted by the Afghan Air Force (AAF) in Dand district and the outskirts of Kandahar provincial center.

50 Taliban militants surrender in N Afghanistan. Amid the unabated violence in Afghanistan, at least 50 Taliban militants surrendered in the country's northern province of Jawzjan as fighting raged in the region, a Defence Ministry official said on Thursday.

# Emergency declared in Greece due to massive wildfires

ATHENS: A state of emergency has been declared in Greece's Varybobi area and the wider municipality of Acharnes in the north of Athens after at least 114 wildfires broke out in a span of just 24 hours.

ANKARA: A thermal power plant in the southwestern Turkish province of Mugla was engulfed by a wildfire, prompting authorities to evacuate people in nearby towns. Gendarmere forces ordered the residents of several neighbourhoods in the Milas district to leave the area immediately.

# US was 'selective' in disclosure, says Huawei CFO's lawyer

VANCOUVER: Lawyers for a senior executive for Chinese communications giant Huawei Technologies argued in court Wednesday that the United States "strategically crafted" a misleading record of the case and acted "in bad faith" when presenting reasons for her extradition.

Meng Wanzhou, who is Huawei's chief financial officer and the daughter of the company's founder, was arrested at Vancouver's airport in late 2018 at the request of the US, which has charged her with fraud. Her arrest infuriated Beijing, which sees her case as a political move designed to prevent China's rise.

Hundreds of people were evacuated from more than 10 villages on the island of Evia, as the wildfire was spreading on four major fronts in the north part of the island, burning houses and forest land since Tuesday evening.

Similar scenes were unfolding at the same time in the municipality of ancient Olympia, the birthplace of the ancient Olympics in north-western Peloponnese. # Israel launches airstrikes on Lebanon in response to rockets

TEL AVIV: Israel on Thursday escalated its response to rocket attacks the previous day from Lebanon by launching rare airstrikes on its northern neighbour, the army and Lebanese officials said.



A statement from the Israeli military said jets struck the launch sites from which the rockets were fired, as well as an additional target used to attack Israel in the past. The military blamed the state of Lebanon for the shelling and warned "against further attempts to harm Israeli civilians and Israel's sovereignty". The overnight airstrikes in southern Lebanon were a marked escalation at a politically sensitive time. Israel's

multiple crises, including a devastating economic and financial meltdown and a political deadlock that has left the country without a functional government for a full year. Lebanese President Michel Aoun said Israel's use of its air force to target Lebanese villages "is the first of its kind since 2006 and indicated the presence of aggressive, escalatory intentions" against Lebanon.

# Iran swears in new hard-line president amid regional tension

TEHRAN: The protégé of Iran's supreme leader, Ebrahim Raisi, was sworn in as the country's new president during a ceremony in parliament on Thursday, an inauguration that completes hard-liners' dominance of all branches of government in the Islamic Republic. The former judiciary chief known for his distrust of the West takes the reins at a tense time. Iran's indirect talks with the US to salvage Tehran's landmark 2015 nuclear deal have stalled, as Washington maintains crippling sanctions on the country and regional hostilities simmer. "The sanctions must be lifted," Raisi said



during his half-hour inauguration speech. "We will support any diplomatic plan that supports this goal." Wearing the traditional black turban that identifies him in the Shiite tradition as a direct descendant of Islam's Prophet Muhammad, Raisi recited the oath of office with his right hand on the Quran. In his address, Raisi stressed his embrace of diplomacy to lift US sanctions and mend rifts with neighbors, a subtle reference to Sunni rival Saudi Arabia. But he also signaled that Iran seek to expand its power as a counterbalance to foes across the region.
