The report also said that more than 90 per cent schools had a hand-wash facility in 2019-20, a major improvement from 2012-13 when it was just 36.3 per cent. MP has seen a little improvement there providing hand-wash facility in 89 per cent schools, i.e. 3 per cent higher than the preceding year.

9 countries...

There have been apprehensions in India that people who took Covishield and Covaxin jabs are unlikely to be eligible to travel to the European Union member states under its 'Green Pass' scheme. The EU Digital Covid certificate or 'Green Pass' will be mandatory to travel to European countries and the document will serve as proof that a person is vaccinated against COVID-19. An EU official on Tuesday said individual member states of the European Union will have the option to accept vaccines authorised by the World Health Organisation (WHO) like Covishield for obtaining the bloc's digital Covid certificate. The meeting took place on the sidelines of a G20 meeting in Italy.

Zydus Cadila...

Expert committee as required under Forest (Conservation) Act, 1980, Section 2 was not constituted within a month, although permission was granted much before.

Advisory committee as required under Section 3 of Forest (Conservation) Act, 1980 has not been constituted. As the mining would intersect ground water and thus necessary permission has to be obtained from Central Ground Water Authority for working below ground water table. But, this has not been done. Working plan for survival of wild life particularly for Avifauna whose nesting trees are to be cleared has not been prepared. Comprehensive Impact Assessment of this project has not been done.

100 PER CENT...

"We got over 68,000 doses, but we could vaccinate more people than the doses. People showed a good response to the drive and, soon, we'll target 100 per cent vaccination in the city," she added. Subdivisional officer of Police (SDOP), Shajapur, Deepa Dodve said that a complaint was received from victims and further action was being taken. "We have received videos and are verifying them," she told journalists.

No suspects were identified or arrested till the filing of this report.

DISQUALIFICATION OF MPS, MLAS

SC refuses to frame guidelines

OUR BUREAU / New Delhi

The Supreme Court on Thursday ruled out framing the guidelines for the Speakers of the Lok Sabha and Assemblies and chairman of the Rajya Sabha to decide the disqualification cases against MPs and MLAs for defection within a timeframe, asserting that the prayers fall in the domain of Parliament.

It, however, fixed the hearing in the matter after two weeks, with Chief Justice N V Ramana presiding over the Bench telling petitioner Ranajit Mukherjee of the Congress to first read his Karnataka judgment and then come back to the Court.

When the counsel for the petition argued that the prayer is to have the guidelines to decide the defection cases in an urgent manner, the CJI told him that the same issue was raised in the case relating to disqualification of the Karnataka MLAs, which was turned down by the court.

Sidhu may become Dy CM or campaign panel chief

FROM OUR BUREAU NEW DELHI

Cricketer-turned former Punjab minister Navjot Singh Sidhu is reconciled to accept either the post of a deputy chief minister or head of the party's campaign committee for the 2022 Assembly elections, after Rahul Gandhi and Priyanka Gandhi, rejected his repeated demand on Wednesday to head the Punjab Congress Committee to replace Sunil Jakhar.

He was told that both the CM and the PCC chief cannot be the Jat Sikhs as the party has decided to rather include more Dalit and Hindu leaders to balance the caste equations. The party sources said Capt. Amarinder Singh was rung up by Priyanka to inform him about the outcome of the discussions with Sidhu. They said Amarinder left it up to Rahul to decide either way as retaining the

state in the Assembly polls is important. They said Sonia Gandhi summoned to Mallikarjun Kharge, who has gone to hometown Bengaluru, for discussions on a 3-member panel he heads to solve the Punjab crisis. The panel, which also includes in-charge AICC general secretary Harish Rawat and former Delhi MP J P Agarwal, has to give its second report to Sonia to facilitate the changes in both the Punjab government and the organisation.

Sources said the chief minister had already conveyed to the Kharge panel during his last visit to Delhi that he would prefer

to induct a Dalit or a Hindu leader as the deputy CM and not Sidhu, who had quit as a minister in July 2019 after he was divested of the minister for local government.

Centre's response

The Supreme Court on Thursday asked the Centre for its response to imposition of President's rule in West Bengal and setting up of a Special Investigation Team (SIT) for probing the causes of the post-poll violence in the state. The SC was reacting to a PIL on the violence going on in the state since May 2, the day the Assembly results were announced, and deployment of the armed or paramilitary forces in aid of the state administrative authorities to bring normalcy in the state.

A bench of Justices Vineet Saran and Dinesh Maheshwari issued notice to the Centre, West Bengal and Election Commission of India on the plea, which also asked the Central and State government to award compensation to the victims and their kin after ascertaining the nature of loss sustained by them in post-poll violence in the state.

Subsequently, Mr. Naveen Kumar Sood IP No. IBBI/IPA-001/IP-P00132/2017-18/10274 in place of Mr. Navin Khandelwal IP No. BBI/IPA-00/I/IP-P00703/2017 has been appointed as RP vide NCLT order no. I/A/12(1ND)2021 in CP(IB) 9 of 2020 dated 28th January, 2021 [herefore, the above results were reviewed by the Management and the RP. These financial results for the year ended 31st March 2021 have been prepared by the management of the Company in accordance with Regulation 33(2) of the SEBI (Listing Obligations and Disclosure Requirement Aules, 2015. These audited financial results were placed before the RP on 30th June 2021 for their consideration. Accordingly, the audited financia esults were considered and recommended in the meeting.
